**Public Trust:** Held public meetings at various locations in the County to increase public awareness of Fish and Game Commission activities and created web page on Mendocino County Water Agency website ([www.mendocountywa.com](http://www.mendocountywa.com)) to improve public access to meeting agendas, minutes and background information regarding the Fish and Game Commission.

**Practices:** Solicited and evaluated proposals for various fish and game improvement projects in Mendocino County.

**People:** Encouraged public participation in Fish and Game Commission meetings.

### GOALS/OBJECTIVES FOR F/Y 2010-11

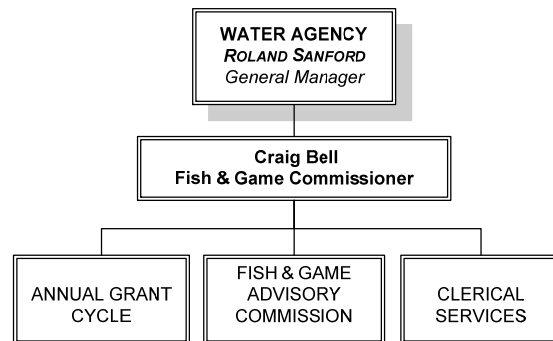
