The final report from Kemper Consulting is expected to be presented to the Executive Office during the first week of February. In order to facilitate an in depth review of the report by the Board, the HHSA Standing Committee recommends that the Board schedule a special meeting on February 16, 2016, with the report to be heard at 1:30 p.m.
