AGENDA TITLE: Approval of Disbanding the Legislative Platform Ad Hoc Committee Consisting of Supervisors Brown and Gjerde and Referring the Development of the 2017 Legislative Platform to the Board of Supervisors' General Government Standing Committee

- PREVIOUS BOARD/BOARD COMMITTEE ACTIONS: On November 3, 2015, the Board approved the formation of an ad hoc committee consisting of Supervisors Brown and Gjerde regarding the development of the draft 2016 Mendocino County Legislative Platform. On January 12, 2016, the Board of Supervisors adopted the 2016 Legislative Platform.
- **SUMMARY OF REQUEST:** Pursuant to County Policy No. 19, the Board of Supervisors adopts an annual Legislative Platform reflecting the County priorities for legislative advocacy, state and federal funding, and issues of interest to local government.

The Board formed an ad hoc committee comprised of Supervisors Brown and Gjerde to work with the Executive Office in development of this year's platform. The Ad Hoc Committee brought forward the 2016 Legislative Platform to the Board on January 12, 2016, and was subsequently adopted. During discussion the Ad Hoc suggested utilizing the standing committee process for the development of the 2017 Legislative Platform.

The Ad Hoc recommends the development of the 2017 Legislative Platform be referred to the Board of Supervisors General Government Standing Committee with a suggested timeframe for development August – October 2016.
