AGENDA TITLE: Adoption of Resolution Extending the Term of the Caspar Transfer Station Operations Agreement and Lease to June 30, 2021

- **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** The Board of Supervisors (BOS) approved Caspar Transfer Station Operations Agreement and Lease (BOS Agreement #11-08) with Solid Wastes of Willits on January 25, 2011, and subsequently made three minor amendments thereto. On March 17, 2016, the Caspar Joint Coordinating Committee recommended extending the contract to 2021.
- SUMMARY OF REQUEST: The County and City of Fort Bragg turned over operation of the Caspar Transfer Station to Solid Wastes of Willits in 2011. The company's operation of the facility and compliance with the BOS Agreement #11-08 has been satisfactory. Unless extended, BOS Agreement #11-08 expires on June 30, 2017, and notice of an extension by County must be made in writing at least 180 days in advance. It is important at this time for the County to state its intentions. Since the County does not wish to assume operation, BOS Agreement #11-08 should be extended. The City of Fort Bragg must concur with the extension. The proposed Resolution would extend the agreement and lease until 2021. An additional extension to 2029 can be made in the future.
