AGENDA TITLE: Discussion and Possible Approval of Disbursement of \$35,000 of Mendocino County Fish and Game Propagation Funds for Round 1 of the 2015-16 Project Cycle

- **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** The role of the Commission is established in Chapter 2.5 of the Mendocino County Fish and Game Code; this role includes recommending expenditures to the Board of Supervisors from the Fish and Wildlife Propagation Fund that are in accordance with the requirements of the Fish and Game Code Sections 13100-13104.
- SUMMARY OF REQUEST: The Commission is requesting that the Board of Supervisors consider and approve recommendations for an allocation of County Fish and Game Propagation Funds in the amount of \$35,000 for various projects for the 2015/2016 Project Application Cycle. Currently, the Fish and Game Commission budget has approximately \$40,000 available for this purpose. An Ad Hoc Committee of three Commissioners met on March 9, 2016 to rank the submitted proposals. The Commission reviewed the rankings and voted to recommend the top three rated projects to the Board of Supervisors for funding.
 - \$5,000: "Sacramento Pike Minnow Abatement Project" by the Ukiah Rod and Gun Club
 - \$5,000: "Mendocino Public Safety, Habitat, and Wildlife Protection" by CA State Parks Law Enforcement
 - \$25,000: "Hammerhead Lake Improvement Part 3 Phase 1" by US Forest Service
