**AGENDA TITLE: Adoption of Private Road Name Petition RN 2015-0005 (Road 19), in Little River, Finding it to be in Conformance with Mendocino County Code 18.16.070**

**PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** Adoption of Ordinance 3376 in 1982, amending Mendocino County Code Section 18.16.070-Names of Roads.

**SUMMARY OF REQUEST:** The Little River Fire Department has unofficially renamed several private roads in their district to help facilitate an accurate response in the event of emergencies. Despite the fact that no petition was submitted to re-name the road through the official process, residents and the local post office have adopted the names into general use, causing confusion between the County records and the 'on-the-ground' information. To remedy this, the Department of Planning and Building Services will sponsor several petitions to officially re-name the roads and eliminate confusion. This petition is to rename 'Little River I Road' to the commonly used *Road 19*. *Road 19* takes access from Albion-Little River Road (CR 403), approximately .80 miles east of its junction with Little River Airport Road (CR 404) and runs south for .47± miles to its end. *Road 19* serves as primary access for approximately 10 existing residences. This petition is consistent with Mendocino County Code Section 18.16.070(b) Names of Roads: "The recommended road name does not duplicate or sound like any existing road name within the various regions of the County.", and has been referred to responsible agencies for review and comment and no comments were received.
