■ **AGENDA TITLE:** **Adoption of Resolution Approving Release of Contract Surety, Department of Transportation (DOT) Contract No. 140023, 2014 Automated Weather Observation System with Altimeter and Visibility Sensors (AWOS-AV), Security Fencing and Rotating Beacon Project at Little River Airport (Little River Area)**

■ **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** By Resolution No. 14-059 (May 6, 2014), the Board of Supervisors authorized DOT to advertise for bids and award DOT Contract No. 140023 to construct an Automated Weather Observation System with Altimeter and Visibility Sensors (AWOS-A/V), Security Fencing and Rotating Beacon at Little River Airport. On August 8, 2014, DOT awarded DOT Contract No. 140023 to Fort Bragg Electric, Inc. of Fort Bragg, California. On October 6, 2015, the Board authorized the Notice of Completion.

■ **SUMMARY OF REQUEST:** The Notice of Completion for DOT Contract No. 140023, 2014 AWOS-A/V, Security Fencing and Rotating Beacon at the Little River Airport, was authorized by the Board of Supervisors on October 6, 2015. The required lien period has passed and a status review indicated that there are no pending claims. It is now appropriate to release the Performance Surety. The Labor and Materials Surety will continue to be held and will be released after the additional six month lien period.
