■ AGENDA TITLE: Adoption of Resolution Establishing the Total Mileage of County Maintained Roads at 1,014.86 miles as of December 31, 2015 (County Wide)

■ PREVIOUS BOARD/BOARD COMMITTEE ACTIONS: On June 3, 2014, the Board adopted Resolution No. 14-074, accepting subdivision roads Tehuacan Road, Barlett Court and Celestin Court within Phase I of Vichy Springs Community Homes Subdivision Unit 2, Tract 245 into the County Maintained Road System. On March 17, 2015, the Board adopted Resolution No. 15-049, establishing the total mileage of County Maintained Roads at 1,014.34 miles as of December 31, 2014.

■ SUMMARY OF REQUEST: The California Streets and Highways Code requires that in May of each year the County submit to the California Department of Transportation any additions to or exclusions from its adopted maintained mileage during the preceding calendar year. The Mendocino County Department of Transportation (MCDOT) has determined that 0.52 miles of road was accepted into the County maintained system in 2014 but was inadvertently not included in that year’s maintained mileage calculation. There were no further additions or exclusions in 2015. MCDOT has recalculated the mileage of County Maintained Roads in the County of Mendocino using current segment length measurements and the most recent functional classifications and determined that the total mileage is 1,014.86 miles which is 0.52 miles more than reported last May. The increase in total mileage is attributed to the addition of Bartlett Road (+0.03) and Celestin Court (+0.13), and the extension of Tehuacan Road (+0.36).
