## AGENDA TITLE: Adoption of Resolution Authorizing the Department of Transportation (DOT) to Advertise for Bids and Award DOT Contract No. 130077 for Construction of the Seismic Retrofit of the Moore Street Bridge over the Russian River, CR 229B, M.P. 0.45, and Increase the Director of Transportation's Change Order Authority to 10% of the Contract (Calpella Area)

PREVIOUS BOARD/BOARD COMMITTEE ACTIONS: By Resolution No. 07-008 (January 9, 2007), the Board authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000, plus 5% of the amount of the original contract costs in excess of \$250,000, and in no event shall any change or alteration exceed \$150,000. By Resolution No. 08-205 (October 21, 2008), the Board approved Board of Supervisors (BOS) Agreement No. 08-185/DOT Agreement No. 080059 with Mark Thomas and Company, Inc., for plans, specifications, and estimate bid package for the seismic retrofit of the Eureka Hill Road Bridge over the Garcia River, CR 505, M.P. 4.92, and the Moore Street Bridge over the Russian River, CR 229B, M.P. 0.45.

■ SUMMARY OF REQUEST: Mendocino County Department of Transportation will prepare and administer the construction plans, specifications, estimates, and contract documents for Contract No. 130077, seismic retrofit of the Moore Street Bridge over the Russian River. This project is for the seismic retrofit of the existing bridge. Construction is anticipated for the summer of 2016, pending project authorization, and the total construction cost is estimated at \$1,416,000. The project is to be funded primarily through the federal Highway Bridge Program (HBP), with the local match funded through the seismic portion of Proposition 1B Local Streets and Roads. Project funding includes a contingency of 10% of the bid construction contract costs. Therefore, it is prudent to allow the Director of Transportation to authorize contract change orders to equal that amount.
