■ **AGENDA TITLE:** **Adoption of Resolution Authorizing the Department of Transportation (DOT) to Advertise for Bids and Award DOT Contract No. 160022 for Construction of the Reeves Canyon Road Bridge Replacement over Forsythe Creek on Reeves Canyon Road, CR 219, and Increase the Director of Transportation’s Change Order Authority to 10% of the Bid Construction Contract (Redwood Valley Area)**

■ **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** By Resolution No. 07-008 (January 9, 2007), the Board authorized the Director of Transportation to execute changes to any DOT contract that exceeds \$250,000 by up to \$25,000 plus 5% of the amount of the original contract costs in excess of \$250,000, and in no event shall any change or alteration exceed \$150,000. By Resolution No. 12-003 (January 10, 2012), the Board approved Board of Supervisors (BOS) Agreement No. 2-006/DOT Agreement No. 110103 with Drake-Haglan and Associates for plans, specifications, and estimate bid package for replacement of the bridge and approaches on Reeves Canyon Road, CR 219, over Forsythe Creek. By Resolution No. 12-134 (October 16, 2012), the Board authorized the Director of Transportation to approve additional amendments not to exceed \$50,000.

■ **SUMMARY OF REQUEST:** Mendocino County Department of Transportation will prepare and administer construction plans, specifications, estimates, and contract documents for Contract No. 160022, Reeves Canyon Road Bridge Replacement over Forsythe Creek. This project is for construction of a new bridge and approaches on an adjacent alignment and removal of the old, structurally deficient and weight limited bridge. The total construction cost is estimated at \$1,800,000 and will span the 2016 summer construction season. The project is to be funded primarily through the federal Highway Bridge Program (HBP), with the local match funded through Toll Credits. Project funding allows for a contingency of 10% of the bid construction contract costs, therefore, it is prudent to allow the Director of Transportation to authorize contract change orders to equal that amount.
