**SUMMARY OF REQUEST:** Adoption of this Resolution will authorize amending the "Cooperation and Repayment Agreement" to include a work plan approved by the Agency, with related implementation not to exceed \$1,300,000, (FY 11-12 expenditures of approximately \$380,000). The costs of this work plan will be initially paid by the County, and then repaid by the Agency, so that there is no net cost to the County's General Fund. Additionally, this Resolution will adopt findings required by California Community Redevelopment Law (CRL) Section 33445, adopt known CEQA determinations, and direct that appropriate CEQA analysis and CRL 33445 findings be made prior to the release of funds for the identified projects.
