■ **AGENDA TITLE:** Resolution Authorizing the Extension of the Mendocino County Abandoned Vehicle Abatement Program for an Additional Ten (10) Years.

■ **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** In 1992 the Mendocino County, Abandoned Vehicle Service Authority was formed pursuant to a resolution passed by the Board of Supervisors. On December 4, 2001, the Board of Supervisors passed resolution number 01-256 to extend the program until April 30, 2012.

■ **SUMMARY OF REQUEST:** Pursuant to Section 22710 of the California Vehicle Code, the Mendocino County Board of Supervisors formed the Mendocino County Abandoned Vehicle Abatement Service Authority in 1992. This Service Authority provides for the imposition of a one dollar/vehicle registration fee for every vehicle registered in Mendocino County to fund the Service Authority's vehicle abatement activities. This funding provides for one code enforcement officer to be assigned full time to enforce Mendocino County Code Section 15.28.010 which was adopted pursuant to Section 22710 of the California Vehicle Code. This County Code authorizes the abatement, removal, or disposal of any abandoned, wrecked, dismantled, or inoperative vehicle or part from public or private property when the vehicle is deemed to be a public nuisance. Between fiscal year 2002/2003 through June 30, 2011, the service authority has received \$890,624.70 and during that time abated 11,382 abandoned vehicles in Mendocino County. The Mendocino County Service Authority sunsets by statute on April 30, 2012. California Vehicle Code Section 9250.7(g) allows each county to extend their sunset date for the program in 10-year increments by passing a new resolution and submitting a formal request to the Department of Motor Vehicles. This resolution will be submitted with the formal request to the DMV and allow the program to be extended until April 30, 2022.
