## RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS SUPPORTING THE COUNTY'S APPLICATION FOR THE REGIONAL TRANSPORTATION COMPONENT OF THE 2012 STATE TRANSPORTATION IMPROVEMENT PROGRAM (STIP) FUNDING AND AUTHORIZING THE DIRECTOR OF TRANSPORTATION, OR HIS DESIGNEE, TO PROCESS SAID APPLICATION (POTTER VALLEY AREA)
