Presenter: County Counsel, Jeanine B. Nadel announced that the Board of Supervisors reports that in regards to Item 9a, SEIU has voted in favor of the proposed Tentative Agreement, which includes:

- A 10% permanent general wage reduction effective the first full pay period after formal approval by the Board
- A labor management committee which will meet the second Thursday of every month
- The term of the agreement will be until June 30, 2013
- There will be an increase in annual Personal Leave hours from 24 to 30
- All previously signed Tentative Agreements (TA's) will be adopted
- All PERB charges will be withdrawn with prejudice
- The Union agrees to the County's new tier of retirement for new hires whenever this is adopted in the future

Board Action: Upon motion by Supervisor Smith, seconded by Supervisor Brown, and carried unanimously, the Board of Supervisors hereby approves the Tentative Agreement as stated above; directs staff to update the MOU and present to the Board in Open Session once the update and review process is completed with SEIU, which is expected to be on February 14, 2012. The salary provision will be effective the first full pay period after today, which is pay period number four (4). The increase in Personal Leave hours is effective pay period three (3).
