■ SUMMARY OF REQUEST: This agreement is for services identified in Mendocino County's approved Mental Health Services Act (MHSA) Prevention and Early Intervention Component of the Three Year Program and Expenditure Plan. Anderson Valley Unified School District in collaboration with Anderson Valley Health Clinic and the Anderson Valley Family Resource Center will provide prevention and early intervention services to children and families including school-based screening and prevention services; paraprofessional services on campus; clinical supervision and services; and community-based family support services. This contract will serve the 540 students at the two schools located in Anderson Valley Unified School District and their families which is 71% Latino with over 50% English Learners. The annual remuneration for this contract is not to exceed \$54,770. This contract will run from September 1, 2011 through August 31, 2012.
