- **PREVIOUS BOARD/BOARD COMMITTEE ACTIONS:** On February 28, 2012 the Board ratified a prior California Reads Grant application.
- SUMMARY OF REQUEST: Request authorization to submit application for California Reads grant augmentation funds for an award of up to \$2,500 in grant monies with the County providing match of in-kind salary of up to the \$2,500 grant amount. The California Council for the Humanities has previously approved the County Library's request for support from the California Reads grant program, and has a limited amount of grant augmentation funds available only for author travel expenses, book purchases, printing of program resource or publicity materials. The County Library would like to invite an author Rebecca Solnit to visit the Ukiah and Fort Bragg branches and purchase multiple copies of invited author's books. Application for additional award monies would facilitate the visit and the purchase of books. The grant submission is due no later than March 30, 2012.
