■ **AGENDA TITLE:** Adoption of Proclamation Recognizing April 2012 as National County Government Month in Mendocino County Celebrating “Healthy Counties, Healthy Families”

■ **Previous Board/Board Committee Actions:** The Board has previously recognized National Co. Government Month; the last occasion was on April 19, 2011. The Board of Supervisors also adopts resolutions and proclamations throughout the year recognizing opportunities to promote health, education, and public safety in keeping with the Board’s Mission: to enhance the quality of life of the people of Mendocino County.

■ **SUMMARY OF REQUEST:** The National Association of Counties (NACo) has designated April 2012 as National County Government Month. This year’s theme is “Healthy Counties, Healthy Families”, focusing on programs that promote health services, wellness, fitness, and overall health awareness. Mendocino County is recognizing National County Government Month during April to highlight essential county government services and programs, and to raise public awareness and understanding about the roles and responsibilities of the nation’s counties to their local communities.

Mendocino County has launched a number of recent initiatives to promote healthy families, and healthy choices to sustain healthy lifestyles. Such initiatives include *Healthy Mendocino*, an initiative of the Health and Human Services Agency; expanded community services through the County library system, including the increased issuance of library cards and expanded services serving our families and communities throughout Mendocino County. Within the County organization, recent advancements have been made to expand county wellness programs, and measures to improve the overall health and wellbeing of our county workforce, while reducing costs throughout the county system.

In recognition of the importance of local government, and the network of services provided to the community on behalf of the employees of Mendocino County, it is requested that the Board of Supervisors adopt a proclamation recognizing April 2012, as National County Government Month in Mendocino County, promoting this year’s theme: *Healthy Counties, Healthy Families*. County representatives will be in attendance to briefly highlight some of the healthy family initiatives underway in Mendocino County.
