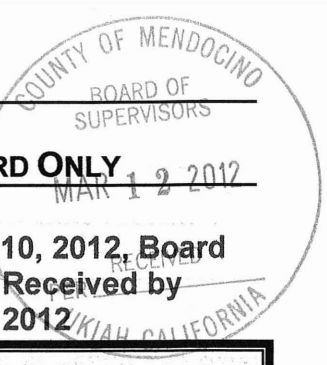

To Whom It May Concern:

As a Chief Business Official within our State K-12 public education system for the past eight years I believe I have the qualifications that would make me an ideal candidate for the public appointee position. Over the past four years I have had an opportunity to work closely with two districts that had relationships with their respective City Redevelopment Agencies. As the CBO in Dixon Unified School District I had an opportunity to begin to explore how Pass-Through Agreements were developed and the parameters associated with them. I was able to participate in meetings with the Solano County Office of Education and the Dolinka Group as the State began exploring ways they could capture or redirect redevelopment agency funding to the State level.

Over the past two years working as the Chief Business Official for Ukiah Unified School District I have had the continued opportunity to develop a more thorough understanding of the background of redevelopment agencies and most recently have continued to explore and learn about the legal challenges up-to and including the impacts of the California Supreme Court Decision relative to ABx1 26 and ABx1 27.

The City of Ukiah Redevelopment Agency and the Ukiah Unified School District have worked collaboratively relative to the existing Pass-Through Agreement entered into in 1989. Over the past two years the District has entered into an agreement to utilize this Pass Through funding towards the building of a new District Office Service Center. As a result of the District's decision to go forward with this project, many concerns have been expressed by the public regarding the use of these funds and alternative options for usage. Once again, this has allowed me an opportunity to learn more about the intricacies of RDA funds and their previously allowable usages, while being responsive to public perception and concerns.

I have worked closely with Cathy Dominico, President of Capitol Public Finance Group and Paul Thompson, District legal counsel from Fagen, Friedman and Fulfroft, LLP. These professional

relationships have provided the chance for me to work very closely with people that are experts within the field of redevelopment agencies, and have their finger on the pulse of many of the changes and challenges that result from the California Supreme Court decisions.

I believe the combination of my background as the Chief Business Official of Ukiah Unified School District, my background and level of experience in both public and private sector business administration over the past 25+ years, and my experience and specific involvement relative to Redevelopment Agencies qualify me for consideration as a candidate for this position.

In addition as an appointed member of the Oversight Board to the Successor Agency of the Mendocino County Redevelopment Agency, I believe participation on both Boards would only provide a better informed member that could assist with the challenges and decisions that lay ahead for the Successor Agency of the Ukiah Redevelopment Agency. Finally, as a community member of this area for over thirty years I have a vested interest in the continued growth of our community and believe as a member of this committee I would be a positive member and contributing part of our local society, committed to equity and transparency in the process the Committee is tasked with.
