JOB SUMMARY AND DISTINGUISHING FEATURES:

This class works under general supervision, performs progressively more responsible task in the repair and maintenance of County vehicles and equipment, performs body and paint work, fabricates and modifies parts for specially equipped vehicles. Incumbents in this class perform skilled technical mechanical work in the repair and maintenance of vehicles and equipment requiring an advanced level of training, skill and experience. Work is performed at an advanced journey level, and incumbents in this class are expected to work with considerable independence, with their work being subject only to periodic spot checks.

ESSENTIAL JOB FUNCTIONS: (All responsibilities may not be performed by all incumbents.)

Performs safety checks and maintenance on vehicles and equipment; prepares associated reports.

Performs hydraulic brake diagnostics and repairs.

Prepares vehicle condition reports for the billing of parts and labor time.

Performs road services including towing of vehicles and road testing to assure reliability and safety.

Performs engine diagnosis and repairs, tune-ups, overhauls, and replacement of parts.

Fabricates special equipment for vehicles and other equipment.

Performs transmission overhauls and repairs or replacements.

Checks, repairs or replaces tires as needed.

Repairs interior and exterior of vehicles and equipment.

Checks and repairs suspension and performs wheel alignments.

Inspects, diagnoses, and locates mechanical and electrical malfunctions; repairs and replaces electrical system parts.

Orders parts and supplies as needed.

Refuels and checks vehicles in and out.

Performs routine garage shop maintenance.

Supervises inmates, work release and community service individuals in the performance of vehicle maintenance duties.

Performs a variety of related tasks at an advanced journey level, under general supervision.

Carries lead worker responsibilities, including day-to-day direction, scheduling, and training.

Advises managerial staff in the technical aspects of the job functions.

Performs other related duties as assigned.

Standard business arithmetic, including percentages and decimals.

Diagnosing and repairing a variety of vehicles and equipment.

Communicating clearly and effectively, both orally and in writing.

Mental and Physical Abilities:

Ability to understand and carry out oral and written instructions, giving close attention to detail and accuracy.

Ability to write simple correspondence.

Ability to read and interpret documents such as safety rules, operation and maintenance instructions, procedure manuals, and so forth.

Ability to deal with problems involving several concrete variables in standardized situations.
