### JOB SUMMARY AND DISTINGUISHING FEATURES:

Under general supervision, performs skilled maintenance and repair of the County's vehicles and equipment and other related equipment. Supervises the work of subordinate personnel. The work consists of performing a variety of complex and responsible technical duties under limited supervision within a frame work of standard policies and procedures.

ESSENTIAL JOB FUNCTIONS: (All responsibilities may not be performed by all incumbents.)

Performs complex repair and maintenance of automobiles, trucks, tractors, graders, caterpillars, gas and diesel engines, and other related equipment and vehicles.

Performs routine lubrications and other service related duties as required.

Repairs equipment in the field as necessary.

Schedules and prioritizes the repair and maintenance of various pieces of equipment.

Assists in the relocation and transportation of light and heavy equipment and vehicles to various service locations.

Performs routine maintenance around the shop and service area as required.

Supervises the preventative maintenance and checks of light, heavy and other related equipment and vehicles.

Performs final safety checks on serviced heavy equipment.

Carries out supervisory responsibility in accordance with policies, procedures and applicable laws including: training in job skills; planning, assigning and directing work; appraising performance; addressing complaints and resolving problems.

Reviews and researches service and repair manuals.

Develops special and innovative replacement parts for new and rebuilt equipment.

Attends seminars and classes on the maintenance and repair of equipment.

Performs body and fender repair work including: welding, cutting, painting, and various other procedures.

Answers telephone and answers questions or takes message as appropriate.

Performs other related duties as assigned.
