JOB SUMMARY AND DISTINGUISHING FEATURES:

This class works under general supervision and performs progressively responsible grounds maintenance duties including mowing, watering, fertilizing, pruning and maintaining landscaped areas of the County parks, buildings, and facilities. Incumbents in this class work within a framework of standard policies and procedures. Work is performed at an advanced journey level, and incumbents in this class are expected to work with considerable independence, with their work being subject only to periodic spot checks.

ESSENTIAL JOB FUNCTIONS: (All responsibilities may not be performed by all incumbents.)

Maintains and repairs park facilities, grounds, etc. including: mowing, watering, and weed-eating grassy areas and trails; trimming and clearing dead wood, brush and trees; raking leaves and other plant debris; repairing damage caused by vandalism and reporting same to law enforcement officials; sweeping paved areas and parking lots; maintaining public garden; picking up trash and emptying trash containers; cleaning restroom facilities.

Applies fertilizer and pesticides to plants, trees, shrubs and lawns.

Operates a variety of power and hand tools utilized in ground maintenance activities.

Performs routine maintenance on various power or hand tools and equipment including lubricating, changing oil and sharpening.

Performs maintenance and routine repairs on irrigation and sprinkler systems.

Moves furniture and other items as assigned; may be assigned to run errands as necessary.

Maintains compost pile for use on grounds.

Supervises inmates, work release and community service individuals in the performance of grounds maintenance duties.

Repairs play equipment in parks.

Performs a variety of related tasks at an advanced journey level, under general supervision.

Carries lead worker responsibilities, including day-to-day direction, scheduling, and training.

Advises managerial staff in the technical aspects of the job functions.

Performs other related duties as assigned.

Using tact, discretion, initiative and independent judgment within established guidelines.

Maintaining and performing routine repairs on all assigned equipment.

Mental and Physical Abilities:

Ability to oversee the work of others.

Ability to read and interpret documents such as safety rules, operation and maintenance instructions, procedure manuals, and so forth.

Ability to deal with problems involving several concrete variables in standardized situations.

While performing the essential functions of this job the employee is frequently required to stand, walk, sit, reach with hands and arms, climb or balance, stoop, kneel, crouch, or crawl, speak and hear, and lift and/or move up to 50 pounds.
