# **JOB SUMMARY:**

Performs treatment and monitoring of judicially committed patients of the outpatient conditional release program as well as patients in state hospitals from the County. Incumbents in this class conduct individual and group counseling, assessment, and treatment of mental health patients.

#### **DISTINGUISHING FEATURES:**

This is a licensed classification; it is distinguished from non-licensed classifications within the Mental Health department by the performance of professional-level counseling and therapy services. This classification is distinguished from the Mental Health Clinician I/II and Senior classifications by the performance of treatment and monitoring services of judicially committed patients by the Forensic Clinician. The Forensic Clinician is further distinguished from the Senior Mental Health Clinician by the supervision exercised by the Senior Mental Health Clinician

# **SUPERVISION EXERCISED:**

No supervision exercised. May serve in a lead capacity. May train other staff.

Provides case management services to obtain housing, employment, education and medical services to CONREP clients.

Arranges discharge of CONREP clients, coordinating transportation and housing arrangements.

Writes policies and procedures relevant to CONREP program.

Conducts individual counseling, treatment plans, and assessment.

Documents appropriate items in clinical patient records.

Write chart notes in accordance with professional standards, state regulations and department protocol, and ensure proper filing either by filing or submitting to the proper area for filing.

Writes court reports.

Communicates with the District Attorney and Public Defender office regarding legal processes.

Testifies in court for CONREP commitments.

Arranges acute hospitalization admissions as needed.

Conducts state hospital liaison visits to patients from counties as scheduled.

Completes state hospital liaison visit reports.

Consults with inter-disciplinary team members.

Conducts group counseling.

Conducts home visits.

Performs urine drug screens.
