JOB SUMMARY AND DISTINGUISHING FEATURES:

Provides generalized health and medical care in the treatment of patients in regards to the prevention, detection, and control of diseases and the promotion of health in a variety of settings (outpatient clinics, public and mental health settings, etc.), usually to an assigned area of the community. Performs more difficult physical screening assessment, makes diagnosis and treats or refers for further medical care according to established medical practices. Initiates and/or assists physicians and/or other professional health care providers in providing patient/client care.

ESSENTIAL JOB FUNCTIONS: (All responsibilities may not be performed by all incumbents.)

Provides primary health care including counseling, prescribing and dispensing medications, treatment of infections, sexually transmitted disease examinations and follow-up and assessment of laboratory findings; identifies the health status of individuals through histories, examinations and appropriate diagnostic and screening tests; performs, interprets, and evaluates diagnostic tests to identify and assess patients= health care needs; formulates treatment plans for patients based on patients=condition; evaluates effectiveness of prescribed treatment plans.

Participates in Quality Assurance program which includes medical record review.

Performs inventory and maintenance of vaccines and other clinic supplies; collects specimens for laboratory analysis; operates special equipment; cleans and sterilizes medical supplies and equipment.

Participates in the operation of public health clinics (i.e., interviewing patients, performing diagnostic tests, giving prescribed treatment, recording data, etc.).

Documents all contacts with patients: completes required assessment reports, computer reports, and billing sheets associated with client activities and visit billing.

Carries out lead worker responsibilities including: training in job skills, assigning and directing work, making recommendations in performance appraisal, and reporting problems to the supervisor.

Maintains and enhances knowledge of public health concerns through attendance at workshops, specialty clinics, protocols, iournals and classes.

Performs minor surgical procedures as trained.

Performs other related duties as assigned.
