#### JOB SUMMARY AND DISTINGUISHING FEATURES:

Performs a variety of clerical and sub-technical work in the preparation of laboratory media and specimens for employees, cleans laboratory equipment, data entry and performs tasks as required in the Public Health Laboratory.

**ESSENTIAL JOB FUNCTIONS:** (All responsibilities may not be performed by all incumbents.)

Performs media preparation and sterilization using different reagents and chemicals; prepares plates with media, labels and checks for sterility by incubating; keeps inventory of media and chemicals; tracks outdated media expiration dates to notify and/or reorder when necessary.

Prepares stool specimens for parasitology by making a slide with the stool specimens and putting through a series of dyes for review by the microbiologists.

Maintains chain of evidence records on human and animal specimens submitted for testing for infectious diseases; checks specimens for leaks and other damage to determine suitability for testing; date and time stamping; transfers submitters= information to lab slips, test run sheets and computer database; routes specimens to appropriate laboratory personnel or proper storage (freezer, refrigerator, incubator, carbon dioxide incubator).

Prepares rabies testing samples on animals suspected to have the virus; immobilizes the head and removes the brain; prepares slide of selected tissue samples for review by microbiologists.

Calibrates and operates automated enzyme assay system to test human urine specimens; assesses specimens for adulteration prior to automated testing; enters test results into database and generates reports; applies mathematical analysis and interprets results for counselors.

Prepares logs, forms and other paperwork; proofreads test result reports; enters test, patient billing and other information into the computer; generates work sheets for the microbiologists.

Inventories all media supplies and laboratory supplies.

Cleans and maintains incubator, water baths, freezers, and refrigerators; ensures counter tops and work surfaces are clean and sterile.

Provides containers to medical, health and/or animal care centers who submit samples for testing.

Retrieves drug and other test specimens as needed.

Assists in answering telephone requests for test results, billing information, and specimen submission protocols.

Performs other related duties as assigned.
